

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is between

“DESHPANDE SKILLING, HUBBALLI”

And

“V.C.B EDUCATION SOCIETY’S ARTS & COMMERCE COLLEGE, LINGASUGUR”

DESHPANDE SKILLING a “not for profit” trust, an impact unit of Deshpande Foundation, India, and a training partner of National Skill Development Corporation (NSDC), involved in the activity of conducting residential employability skills training programs for graduates of rural and semi urban colleges at its skilling campus in Hubballi, and providing placement assistance to its students. Deshpande Skilling is desirous to bring about rural transformation by building employability skills among graduate youth from rural and semi urban colleges and assist them earn their first employment in the formal sector.

V.C.B Education Society’s Arts & Commerce College, Linagasugur. has been imparting undergraduate courses to students to earn their Graduation degree from the University. The college is keen to equip its students with skills needed for the present competitive job market.

Terms and conditions of the MOU are as under:

- This MOU shall be valid for 1 year from the date of execution by both the parties.
- The Principal of the college shall permit and make arrangements for the staff of **Deshpande Skilling** to counsel and orient final year students of the college on job opportunities, skill gap between industry requirement and student and on skilling program.
- The Training and Placement cell/Career Guidance cell of the college shall take extra initiative to bring the awareness among the students about **Skilling Programs**.
- The college shall permit and arrange counseling sessions for students by staff of Deshpande Skilling on the college premise.
- Deshpande Skilling will assess final year students of the college and provide opportunity to qualified students to participate in direct placement drives conducted by Deshpande Skilling at its Hubballi center.
- Students of the college who could benefit and who seek admission to the skilling programs of Deshpande Skilling will be assessed and offered admission based on selection criterion.
- **Deshpande Skilling will offer fee concession to selected students of the college who are financially challenged (from a BPL/Antyodaya card holding family) for admission to its skilling programs.**
